Purpose

To provide an overview briefing on the Army Leader Development Program (ALDP) and highlight leader development initiatives pertaining specifically to Warrant Officers

Army Leader Development Program

- The Army Leader Development Program (ALDP) merged existing Army leader development (LD) initiatives and management processes into a single program
- HQDA approved LD initiatives from Army Leaders for the 21st Century (AL21) and Army Initiative #5 (AI5) formed the basis of ALDP initiatives
- The ALDP was formally established on 21 Dec 07 with the signing of the ALDP charter by the SA and CSA

Prepare the Army (PA) Forum

- The PA Forum is focused on execution of approved Army LD initiatives
- The PA Forum provides Supporting Command and Lead Agent representatives opportunities to collectively address ALDP issues
- Supporting Commands submit recommended adjustments to ALDP and/or the Integrated Priority List (IPL) resourcing/policy for CG TRADOC approval
- Lead Agents provide status of ALDP initiatives, submit PPBE-derived resource requirements, request approval for resource adjustments, and coordinate all policy changes affecting ALDP with CG TRADOC

PA Forum Purpose, Concept and Endstate

Purpose: Track ALDP execution; arbitrate new initiatives; and establish / maintain the ALDP IPL as a tool for tracking and arbitration

Concept: Deliberative body of senior Army leaders that meets quarterly to:

- establish and maintain ALDP IPL
- review / make recommendations for ALDP policy
- assess ALDP initiatives progress
- prioritize / re-prioritize ALDP initiatives
- make resourcing recommendations
- issue guidance / directives to lead agents to close / modify / accomplish ALDP initiatives

Endstate: Driven by an approved IPL, an integrated, executable, well resourced Army Leader Development Program across all cohorts, domains and components of the Army
